4. To enlighten the students on the importance of human rights.

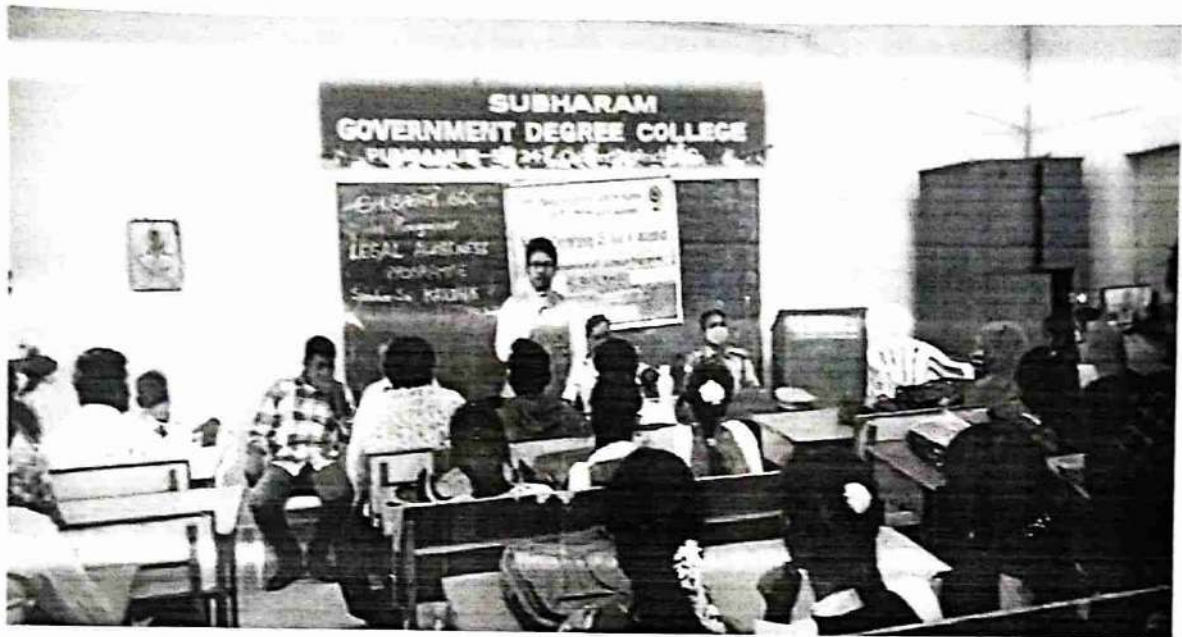
