3. 4. Both parties, being legal entities in themselves desire to sign this MoU for advances their mutual interests.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE T O AGREES AS FOLLOWS:**

### Clause 1: Cooperation

5. Both parties are united by common interests and objectives and they shall established channels of communication and cooperation that promote and advance their respective operations with in the Institution and its related wings.

7. The general terms of co-operation shall be governed by this MOU. 8. The second party would be a major partner for the first party on all social service activities, Extension and personality Development activities and to inculcate service attitude, Human values and ethics among the students.
9. Collaboration in Extension activities of the First party by the second, dissemination of knowledge for the students of the first party and employees and members of both parties.
10. The Second party will reach out to the students to conduct awareness programmes, social service activities, to teach values and Ethics, to develop life skills, personality development programmes etc., The Faculty and students should take part and participate in the social service activities of the second party co-operating each other. Which will be informative and promotional in nature?
11. The second party will work with the extension wings of the first party like NCC, NSS, WEC, YRC, RRC, JKC students union, staff council and other academic bodies to prepare the plan of action, data collection process and organizing events.
12. Co-operation between both parties would be extended to any other area which may be mutually beneficial to both the organizations ,

## **Clause 2: Scope of the MOU.**

13. The budding graduates from the institution would play a key role in social service and extension activities, environmental protection, CSP, Internship, Human values and Ethics and to establish a peaceful society. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their life skills and knowledge.

17. To extend mutual necessary support to deliver guest lecturers to the students of the first party and to provide support and assistance to the service activities being conducted by the first party.
18. Both parties to obtain all internal approval, consents, permissions of what so ever nature require for mutual benefit.
19. There is no financial commitment between the parties; no financial assistance will be given for any activity by both parties.
20. The second party will help the students of first party in execution of their community service projects and Internships.
21. In case, both the parties wanted to conduct commercial training than this agreement can be amended/ by adding annexure with mutually agreed terms.

### **Clause 3: confidentiality.**

22. Except may otherwise be required by law, each party will hold confidential, during and after the term of this agreement, any confidential information should not be disclosed to it or its representatives any such confidential information to any third party.

### **Clause 4: Validity.**

23. The period of the agreement is valid for a period of 5 years from the date of signing of this agreement.
24. This agreement will be valid only at the intentions of the parties involved therein, this MOU could be dissolved or cancelled by either party any time by giving 30 days' notice and shall not have any legal bindings in nature. Should either or all the parties to it opt to not act upon, the MOU loses its validity.
